Stakeholder surveys

It is a crucial part of our role as your Governing Body that we understand and act upon the views of our stakeholders. We have therefore continued with our stakeholder surveys for parents/carers, children (Pupil Voice), in-year leavers prior to end of year 6 (exit survey), children with special educational needs and disabilities (SEND), year 6 leavers and all Oaklands Junior school staff. These surveys enable us to make comparisons and changes where needed. Thank you to everyone that has kindly taken the time to complete the parent/carer survey, your responses are greatly appreciated. We will feedback the planned initiatives in response to the survey feedback in our Autumn newsletter.

Parent survey results 2023

We are delighted that we had 131 responses, which means 62% of our parent community completed the survey. We aligned our survey questions with the same questions Ofsted ask when they complete the Parent survey during an Ofsted visit. Overall there is a rise across all areas in percentage overall agreement. Read the results in full **here**.

Attendance % and Pupil admission number (PAN)

We want to visibly and substantively improve the community we are embedded within. Part of our strategic plan focuses on our school occupancy numbers and attendance. I am pleased to report school attendance has been **96.24%** this academic year. In line with the Department for Education net capacity assessment, we can accommodate 32 children per class, and as we are a two-form entry school our year groups have 64 children each – total capacity is 256 children. I am delighted to report that this year we have been **99.2% full** and next academic year we will continue this trend with years 4, 5 and 6 full – 100% capacity, with a waiting list. In September we are not currently predicted to be full in year 3. Please support us in our common goal to reach 100% occupancy and recommend your school to prospective parents that need a place for their child.




Learning Trust

Safeguarding training

Gary Burridge attended a two session safeguarding training course and had the following feedback

The Governor Safeguarding training was incredibly informative, the training was broken down into two primarily areas:

Safeguarding issues faced today in schools and how they can be identified with best practice guidance for schools

The responsibilities of the governing bodies in ensuring the school has a safe environment with regards to Safeguarding

The training highlighted the volume of safeguarding related incidents that are happening not only nationally but locally, and that abuse is not limited to socioeconomic factors, but there are a variety of situations that can trigger abuse inside and outside of the school that responsible individuals within the school need to be vigilant with.

The Training highlights the need for strong Safeguarding and Anti-Bullying policies, that is understood and implemented by all in the school (Staff and Pupils), so that Adults in the school are trained and aware of the signs of abuse and are clear on the escalation protocol when concerns are identified.





Finance and Premises Committee Report 2022 - 2023

Learning to Think and Thinking to Learn, the Oaklands' mindset for the entire school community.

Our thinking school provides a solid learning environment to inspire, motivate and challenge our children to reach their full potential. The environment is created by the headteacher and staff but requires high-quality facilities and sufficient funding. It is the duty of the Finance and Premises Committee to ensure strong financial management resulting in the best possible use of our schools funding and premises. The aim and purpose of the committee is simple, what will give the maximum benefit to our children.

With an annual income of circa £1.2m, monitoring expenditure is key. Threequarters of the income is spent on staff costs with the remainder split between learning resources, running costs and maintenance of our buildings and grounds. Even with a tight budget, the school is progressive, with a plan for projects into the future ensuring continual improvement of our school.

Regular maintenance is essential, and the committee undertakes two internal and external inspections of the school and grounds each year. This enables us to identify and record any issues that need addressing plus monitor the progress of anything detected on previous inspections. Inspections are undertaken by two school governors in conjunction with the site controller.

Issues noted during an inspection along with reparation progress are monitored at the quarterly Finance and Premises committee meetings until any required works have been completed. This allows us to prioritise the more urgent jobs but also look at the long-term planning for larger more costly undertakings.

Large projects require additional funding over and above the allowance within the school budget. In this instance, proposals are prepared and issued to the Corvus Trust board for consideration with respect to the funding. All schools in the Trust have to adopt this approach and the Trust makes the decision on which projects go-ahead. I am pleased to announce that our school has recently secured funding on a four-year project to replace the entire electrical system and perimeter fences.

The school is extremely well managed and successfully navigated this financial year without exceeding the tight budget constraints. There are no surplus funds to carry forward and as such, a balanced budget for 2023 – 2024 has been submitted to the Corvus Trust board. Significant increased costs for utilities along with the effects of inflation have resulted in the school having to make difficult decisions with respect to expenditure. Rest assured, the children's education, safety and well-being have all been at the forefront of these decisions. The F & P governors are satisfied with the school's approach and along with strong management of the budget know every effort will be made by the school to secure additional funding from other revenue streams. PTA and voluntary school donations will help significantly, and I hope, once again, our parents will be able to assist us with these revenue streams.

Year 6 KS2 SATS results 2023

Congratulations to our outstanding year 6 children on their KS2 SATS results. With 87% achieving the expected standard in reading, 78% achieving the expected standard in writing and 95% achieving the expected standard in maths. All of the results are significantly higher than the comparable 2023 national results. We look forward to being able to share the comparison with the local results when this is published in September.
